with young Namibians being particularly affected (46%)




0.576 Gini Coefficient

 Supports food security, water sustainability, job creation, and rural development through inclusive agricultural and fisheries value chains.




- Agro-processing clusters and farmer cooperatives

 Promotes youth empowerment, cultural preservation, and economic diversification through creative industries and tourism development




- Job creation through sports, tourism, and creative entrepreneurship

- Aligns with NDP6 objectives to reduce inequality and improve living standards.







Working Group 10: Infrastructure & Connectivity



 Supports SMIP and NDP6 priorities on connectivity, trade facilitation, and digital transformation, positioning Namibia as a regional logistics and digital hub.



- Modernisation of transport corridors, ports, rail, and aviation
- Expansion of broadband and nationwide digital access
- E-government, smart infrastructure, and cybersecurity frameworks
- Reduction of trade costs and streamlined border procedures
- Linkages with fintech, e-commerce, and tourism sectors

Guidance on recommendations:

- Public and private sector agree but implementation is slow e.g. implementing the Namibia Investment Promotion and Facilitation Act
- Matters where further engagement is still required e.g. percentage shareholding in Mining Industry
- Matters where there is a difference in opinion e.g. ownership of land by foreigners in the Land Bill currently before Parliament



NamPPF Working Group Reports

Each working group is to co-develop and submit a strategy paper and a presentation structured as follows:

- Defined scope and focus of the WG
- Highlight understanding and appreciation of national priorities (V2030, NDP6, SMIP, Sectoral/Issue specific strategies
- Potential of private sectors to enable or contribute to growth and Job creation in this sector
- Key constraints and barriers to realising national aspirations
- Practical recommendations and/or requests
